

## Are Dems About To Be Slaughtered This November?

It's no secret that the GOP is expected to do well in the mid-term elections, but a new poll suggests Dems could be looking at a bloodbath.

According to the University of Virginia's widely monitored Crystal Ball, 2010 has the makings of 1994 - the year of the Republican landslide in the House with a Democrat in the White House.

Those results are consistent with a Gallup poll that showed the Republicans with a 10 percentage point lead over the Democrats - the widest margin in 68 years, writes the FT.

Separately, a University of Buffalo paper has predicted a 51-seat gain for Republicans in November. (The GOP needs 39 seats to wrest control of the chamber.)

However politics is fickle and sentiment could shift on a dime.

In fact, House of Representative control has been an elusive task for the Republican Party, historically. Prior to the landslide victory led by Newt Gingrich in 1994, the Democratic Party has controlled the House of Representatives all but 4 of the previous 72 years.
