




Peter Hare Retires

Kurtz Receives Prestigious Norton Medal

he Chancellor Charles P. Norton Medal, UB's highest tribute, is presented annually

in public recognition of a person who has, in Norton's words, "performed some great thing which is identified with Buffalo — a great civic or political act, a great book, a great work of art, a great scientific achievement, or any other thing which in itself is truly great and ennobling and

which dignifies the performer and Buffalo in the eyes of the world,"

Professor Emeritus Paul Kurtz was awarded the Chancellor's Medal this year at UB's commencement ceremonies on Sunday, May 13th. A reception honoring Paul followed at the Center for Inquiry .

A Toast to Paul Kurtz (given at the reception honoring Professor Kurtz)

May 13, 2001

I could nostalgically reminisce at length about Paul. He and I had many of the same teachers at Columbia University — we are both card-carrying members of the Columbia School of Pragmatic Naturalism — and Paul and I have been colleagues in the UB Philosophy Department since he came to UB in 1965 — I had arrived three years earlier. But this is not the occasion for such reminisces.

Nor is this an occasion in which it would be appropriate for me to explain and defend Paul's intellectual and moral commitments. That would be preaching to the choir. If you weren't familiar and sympathetic with his philosophy you wouldn't be here.

No, what I want to say on this occasion is simply that UB is proud, very proud, of Paul. For his many distinguished achievements he richly deserves the Chancellor Norton Medal that he received at graduation ceremonies earlier today. Paul's fame is extraordinary. Though such philosophers as Richard Rorty and Hilary Putnam are more celebrated in the academy, to the general public Paul is far more

widely known than any of those people. His fame has done much to put the City of Buffalo and the University at Buffalo on the world map. For many people abroad the only thing they know about Buffalo and UB is that that is where Paul Kurtz comes from. Paul is almost the most famous professional philosopher in the world. The only philosopher more famous is ... Pope John Paul II.

I would like to propose a toast to UB's favorite son Paul Kurtz, the second most famous philosopher on this planet — to Paul!

100th Birthday of Husserl's Logical Investigations

In 2000, Husserl's Logical Investigations marked its 100th birthday. Many conferences were held the world over to celebrate this occasion, but perhaps the most noteworthy event took place in Prostejov, a small Czech town where Husserl was born. Scholars from 25 nations attended a conference, which included the dedication of a bronze relief of Husserl's bust that was mounted on the wall of the city hall. At this conference, Kah Kyung Cho presented an evening plenary session paper on "Between Constitution and Analysis", and also dedicated a two volume English translation of Logical Investigations by J. N. Findlay to which Cho wrote a new Introduction.

Cho received a grant from the Alexander von Humboldt Foundation for research this summer at the Marbach Library and to hold lectures at Lüneburg and Würzburg Universities.

In October 2001, Cho will speak at Peking University where the Research Center for Phenomenology was recently founded. Cho has been appointed to the International Advisory Board of the Center together with four other phenomenologists: R. Bernet, Director of Husserl Archives in Louvain, Klaus Held, Wuppertal University, John Sallis, Pennsylvania State University, and Lester Embree, Florida Atlantic University.

In the same month, Cho will be a speaker at the Kansai University in Osaka, Japan where he will be paired with Augustin Berque, a noted specialist of Japanese Philosophy from Paris on a topic of climatological phenomenology. Kansai is the university where **Mark Meli** (Ph.D. 1997) just started his full-time teaching in philosophy and English literature.

Festschrift for John Corcoran

John Corcoran, Professor of Philosophy and long-time chair of the interdisciplinary Buffalo Logic Colloquium, was this past year honored in a special double-issue of the international journal History and Philosophy of Logic. This Festschrift volume, which "recognizes the significant contributions made by John Corcoran to the ... history and philosophy of logic", begins with an article "The Work of John Corcoran:



An Appreciation" and ends with a bibliography of Corcoran's published writings; over 50 journal articles, over 100 reviews, and over 25

abstracts and three edited books. The core of the volume is eleven new articles by logicians, mathematicians, linguists, and philosophers from the United States, Poland, Spain, England, Brazil, Switzerland, and Canada. The honor, arranged by the editor of the journal, Peter Simons, of the University of Leeds working with two of Corcoran's former UB students, Stewart Shapiro and Michael Scanlan, who are full professors at Ohio State

University and Oregon State University, came as a complete surprise to Corcoran, even though it had been in progress for more than two years. See page 6 for Scanlan and Shapiro's Introduction to the Festschrift volume of History and Philosophy of Logic in honor of John Corcoran.

Jiyuan Yu taught an new upperlevel undergraduate course on Virtue Ethics.


Visiting Faculty




Mustafa Al-Nakeeb (Ph.D. 1999) recently accepted an Assistant Professorship at Bilkent University in Ankara, Turkey.



The Work of John Corcoran: An Appreciation

1. Introduction

This Festschrift number of History and Philosophy of Logic recognizes the significant contributions made by John Corcoran to the fields represented in the title of this journal, History of Logic and Philosophy of Logic. His insightful and original writings are catalogued in the accompanying publication list. In this paper we do not attempt a comprehensive survey of his work. Instead, we attempt to provide a reader's guide to some important themes in this published oeuvre. Inevitably, this means that some choice nuggets have been left out. One locale for these nuggets is the many reviews that he has produced continuously over the years for Mathematical Reviews. Our own personal experience has shown that he labours over these with the same dedication to the material under review and all provide a good general insight into the subject discussed in the reviewed material.

But publication is not the only reason for John Corcoran to receive the honor of a Festschrift. The contributors, his students, and many others recognize that his personal interactions have facilitated immensely the development of these fields. To spend time with him is to be in the midst of a flurry of phone calls and faxes. Philosophy and writing is a dialogue experience for him. To think is to explain your ideas to another person. We, as his students, have benefited immensely from this close intellectual interaction with a master scholar and thinker. But many who are not his students, his colleagues in many diverse areas of history, logic, and philosophy, have had similar experiences which have enriched their own work. It is with this in mind that this Festschrift number is dedicated to John Corcoran. . . .



1. The translation of the concept and the words used to translate it.

The earliest translation of the word 'sublime' into Japanese I have been able to find comes from 1879. It has as its origin the section entitled 'Rhetorics and Belles Lettres' of the encyclopedic Information for the People, published by the English brothers William and Robert Chamber, and was translated by Kikuchi Fumoto. What we find there is a short entry describing the meaning of the term 'sublime' in relation to literature, the term here translated by the word 'tetto' (快意) with the Japanese translateration of 'sublime' attached to it as a gloss. Tetto, a word that today has all but completely fallen from use, carried in ancient Chinese writings the meaning of 'doing as one will.'


December of 2000 serve to frame a century containing the movement that has been called "Analytical Philosophy." We do not yet have to write a eulogy of Analytical Philosophy in order to declare that it is likely that most of the tools have been probably inaugurated, and some of them, at least in their philosophical applications, possibly exhausted — logical and linguistic analysis, the importation of certain considerations and methods from the natural sciences, for example.

What were its most startling successes? What were its most grievous failures? Will 20th century analytical philosophy count as a major episode in the history of philosophy? Is it possible that any of its representatives will rank as great philosophers who made lasting contributions to philosophy? Most importantly perhaps, what is *true* in what analytical philosophy broadly had to say?

It is hoped that papers in this conference will my to look at analytical philosophy in the 20th century as we might any period in the history of philosophy. What were its greatest and distinctive questions, and its most successful works and arguments? In what sense was this movement in the 20th century an outgrowth of developments already well underway in the 19th, such as mathematical and logical analysis, positivism, and pragmatism? Which aspects of 20th century analytical philosophy are likely to continue in future philosophy that was inspired by it: which themes and methods are likely going to remain with us for some time (and which not)?
