Baldy Fellowships in Interdisciplinary Legal Studies

Yun-Ru Chen is a 2013 graduate of Harvard Law School's Doctor of Juridical Science (SJD) program and a Research Fellow (2013-2014) of the Institute for Global Law and Policy, her research focuses on the construction of family law and market law starting from 19th century Germany and Japan, and all the way to early 20th century Taiwan.



Laura R. Ford completed a PhD in Sociology at Cornell University (2014), earned an LLM in Intellectual Property Law and Policy from University of Washington Law School (2006), and a JD from Tulane Law School (2000). Her historical and comparative dissertation traces the emergence and expansion of intellectual property.

This workshop sought to use the vulnerability lens to explore insights and create opportunities that might develop the concepts and vocabulary to allow us to confront foundational neoliberal assumptions and move to a paradigm that emphasizes the universality, constancy, and inevitability of human dependency and vulnerability.

September 11-12, 2014

"More-than-Human Legalities: Advocating an Animal Turn in Law"

While nonhuman forms of life render many legal operations—in fact, law's very existence as such—possible, legal norms and systems also constitute nonhuman life and render it meaningful in a variety of ways. Up until now, however, scholars have relegated the legal investigation of nonhuman life, and of the animal question in particular, to the typically reformist discourse of animal rights. Within this discourse, legal rights extend to certain nonhuman animals through the same liberal framework that has afforded human rights before it. This interdisciplinary workshop proposed a new subject of inquiry: more-than-human legalities. It urged scholars from a variety of backgrounds and disciplinary orientations to envision what legal frameworks that move beyond the humanistic perspective might look like.

October 10-11, 2014

"Opportunities for Law's Intellectual History"

The goal of this conference was to explore the possibility that methods and materials of intellectual history might be used to shed light on topics related to law that are not traditionally associated with the field of intellectual history. We chose four topics for discussion: bureaucracy, capitalism and risk, doctrine, and popular culture. These topics were not been selected because they are matters of current academic concern on the part of legal historians; rather, we chose them in large part because they are not.
