C. Baldy Center Fellowships in Interdisciplinary Legal Studies

The Baldy Center continued its fellowship program for scholars pursuing important topics in law, legal institutions, and social policy during the 2024-2025 academic year and welcomes two new postdoctoral fellows. Fellows are expected to participate regularly in Baldy Center events, but otherwise have no obligations beyond vigorously pursuing their research. Fellows receive standard university research privileges (library, Internet, office space, computer, phone) and are encouraged to develop collaborative research projects with University at Buffalo faculty members where appropriate.

2025 Senior and Mid-Career Fellows

Jacob Eisler is The Baldy Center Mid-Career Fellow for the fall semester of 2024. During his time at The Baldy Center, he will pursue a set of projects at the intersection of legal doctrine and moral philosophy, examining the relationship between state institutions and the conditions of popular democratic autonomy.

These projects include 'Towards Populist Primacy', describing the alternative theory that the Roberts Court has promulgated regarding the legitimate role of the judiciary in shaping democracy; 'Anti-Corruption Abolition', identifying the Supreme Court's unique willingness to undermine the substance of criminal anti-corruption law, demonstrated in the 2024 term by *Fischer v. United States* and *Snyder v. United States*; and 'The Closing of the Open Society', an early stage book project drawing a connection between contemporary political crisis and loss of socioeconomic mobility in Western society. He looks forward to the community and deep interdisciplinary expertise of the Baldy Center to develop these projects.

Eisler joined Florida State University College of Law in 2023 as the James Edmund and Margaret Elizabeth Hennessey Corry Professor. Professor Eisler researches in the areas of constitutional law, election law, criminal law (focused on anticorruption law), legal theory, and law and technology. He applies moral and political theory to questions of judicial reasoning and institutional design, with a focus on the relationship between legal doctrine, democratic self-rule, and the conditions necessary for political liberty.

Eisler is the author of "The Law of Freedom: The Supreme Court and Democracy" (Cambridge University Press, 2023), and his scholarship is published or forthcoming leading law reviews and peer reviewed journals, including the Emory Law Journal, the UC Davis Law Review, the Pennsylvania Journal of Constitutional Law, and the Election Law Journal. He is regularly interviewed or quoted in leading media outlets nationally and internationally on matters related to the law and politics.

At Florida State, Professor Eisler teaches Constitutional Law I (Structure), Constitutional Law II (Rights), and Criminal Law. He has past experience teaching subjects including tort law, jurisprudence, and EU law. Prior to joining Florida State,

Professor Eisler taught at Jesus College, University of Cambridge as the Yates Glazebrook Fellow and college lecturer in Law, and the University of Southampton as an associate professor (Reader) in Public Law. Before entering the legal academy, he clerked on the Second Circuit Court of Appeals for the Honorable Gerard E. Lynch in New York City, and practiced as an international capital markets attorney in London with Allen & Overy and Herbert Smith Freehills. He received his J.D. from Harvard Law School and his Ph.D. from the Harvard University Department of Government, his MPhil in political thought and intellectual history from the University of Cambridge, and his B.A. in political science and English from Williams College. Professor Eisler is New York bar qualified.

2024-2026 Postdoctoral Fellows



Meghan Dawe is a sociologist whose research investigates law and society through the lens of legal education and the legal profession, and particularly how social and economic inequalities are reproduced through lawyers' careers. As a postdoctoral fellow at The Baldy Center, Fall 2024, Dawe will draw on quantitative and qualitative data to analyze race and class-based differences in student loan borrowing and repayment, and how student debt shapes the careers of law school graduates;

Research topics include: how geography and markets shape lawyers' professional opportunities, experiences, and rewards; the role of national context in shaping lawyers' career aspirations in the United States and Canada; and the social structure and hierarchies of the American legal academy.

Dawe received her PhD from the University of Toronto. Prior to joining The Baldy Center, she was a Resident Research Fellow at Harvard Law School and a Research Social Scientist at the American Bar Foundation.



Walker Kahn joins The Baldy Center in Fall 2024 as a postdoctoral fellow. He studies court systems, financial markets, and debt collection processes. Kahn's research examines how mortgage foreclosure litigation links financial markets to the precarity experienced by everyday people.

Kahn focuses on how financialization has changed the social organization of mortgage foreclosure, how financial sector actors work to degrade legal rights and processes that protect

borrowers, and how judges manage conflicts between new debt collection practices, courts' resource constraints, and the formal demands of legal procedure. He received his JD and PhD from The University of Wisconsin, and his work has been supported by the NSF Law and Science Program and the Center for Engaged Scholarship.

Daniel Mazurek, PhD, (International Cultural Studies, University of Galway) is a research fellow at The Baldy Center, starting Fall 2024. Mazurek conducts research that foregrounds a cultural/arts practice approach to social and political phenomena.

Mazurek is the author of Conspiracy Culture's Action and Aesthetic (Palgrave-Macmillan, forthcoming), which challenges the current doxa of popular and institutional responses to the apparent surge in conspiracy theorizing in the 21st century. He is presently working on a monograph which traces the feedback loop between state funding of the tech sector, popular-science writing and science/tech coverage in the newspapers of record, and the tech sector's instrumentalization of millenarian cultural fantasies of neuroscience and digital media in the 1980s and 1990s. Mazurek's strong interest in media literacy and



Daniel Brantes Ferreira is a professor at Universidade Cândido Mendes and Vice-President for Academic affairs at the Brazilian Center of Arbitration and Mediation (CBMA), where he is an arbitrator. Daniel is also President of the Brazilian Bar Association, Rio de Janeiro Section, Legislative Affairs Commission. Research topics: legal theory, legal history, legal education, comparative studies, and Alternative Dispute Resolution (ADR). Daniel is a partner at Bruno Freire Law Firm where he practices labor law and torts.

At The Baldy Center he is researching American Legal Realism. In January 2021, Brantes Ferreira was interviewed by Brazil's major newspaper, *Estadáo*, about his perspective on Trump's call to Raffensperger and it's legal repercussions.



Jennifer L. Gaynor works on Southeast Asia and its surrounding seas from the seventeenth century to the present. The author of *Intertidal History in Island Southeast Asia: Submerged Genealogy and the Legacy of Coastal Capture* (Cornell University Press, 2016), she has contributed chapters to a number of books, including *Blue Legalities* (Duke University Press, 2020), edited by Irus Braverman and Elizabeth R. Johnson. Building on her previous research, her current book projects examine the history of capture, slavery, and piracy in maritime Asia, as well as the recent history of global land reclamation.



Charles J. Whalen, an economist with a career spanning three decades, has contributed to national economic policy discussions, equitable regional development, and business success. During his appointment at The Baldy Center, Whalen has been active—as president (2018), past president (2019), and trustee (2020-)—in the Association for Evolutionary Economics. Last year, Whalen's AFEE presidential address—on reclaiming the right to work as a progressive cause—appeared (in versions of varying length) in Buffalo Legal Studies Research Paper Series,

Journal of Economic Issues, and Challenge (an economics bimonthly).
