 - Move medical school to Downtown Campus
 - Revitalize South Campus as a "professional studies campus"
 - Relocate Social Work and GSE
 - Renovate older buildings and demolish old/temporary buildings
 - Consolidate school of public health and dental school
 - Refill empty medical school buildings
 - Reorganize North Campus as an "undergraduate and research center"
 - Improve campus life experiences at all three centers
 - Create 'heart of campus' centers (Abbott Hall and 1Diefendorf)
 - Improve library experiences
 - Enhance/create recreation options (master plan & Clark Hall)
 - Reduce (deferred maintenance and address priority infrastructure)
 - Capital Projects:
 - Townsend Hall administration use, exterior renovation ongoing now
 - Parker Hall Social Work, eta 2022
 - Allen Hall Community Relations and Buffalo Prep eta 2020
 - Crosby Hall undergraduate school of architecture eta 2021
