University Shared Governance

- Promoted Prodigy Program to increase diversity among faculty.
- Q/ Hope that the lines will be made permanent after three years.
 - A/ Agreed, this would be good.

Ken O'Brien, Emeritus Professors

- Reflections on shared governance...
- What is its goal..?
 - o Have a voice in important decisions.
 - o Communication among groups to identify problems & opportunities.
 - Collaboration across constituents.
 - o Hunting for the sweet spot, compromise.
 - o Results in better decisions.
- What are best / worst examples?
 - Early inclusion, ideally during problem definition
 - e.g. Fredonia model (vision and buy-in from beginning, including union).
 - o Ignoring the results of participatory efforts (e.g. ignoring a survey).
 - No involvement by local senior leadership in this meeting
 - NB. UB President & Provost are out of town today.
 - Honest open discussion that leads to results and breaks down barriers
 - Dismantlement of a department without involvement of faculty, resulted in uproar and removal of president and provost
- What are threats to shared governance?
 - Lack of funding
 - Inaction/complacency
 - o External threats such as for profit companies
- Effective shared governance over time emphasizes the whole, is pluralistic, and brings more voices and experience to the table.
