

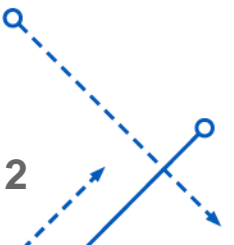

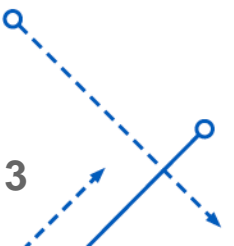
MCFH Timeline

- LOI Submission Window
 - March 31-April 24
 - LOI applicant webinar Thursday, April 3 at 1:00
- Invitations for Full Proposals
 - June
- Grant Decision
 - Late September & early December



Process for Submission

- MCHF LOIs are **due on Thursday, April 24**.
- The **Corporate & Foundation Relations office** will upload all LOI documents and submit on your behalf. Let me know by April 8 if you plan to submit.
- **Please submit your LOI to the CFR Office by Tuesday, April 22 at 5:00.** If not received by the deadline, we cannot guarantee submission.
- MCHF anticipates that the LOI format should look very similar to last year's, although we'll need to verify once they open the portal on March 31.
- Although these are LOIs (and thus CLICK shouldn't be required), **PI's should work with SPS** to develop their draft budgets (which need to be submitted on MCHF's Excel budget template - also available on March 31). Despite reference to 15% IDC on the MCHF website, the UB policy has been no indirect costs on MCHF grants.

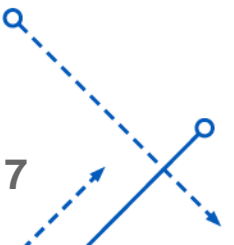
Special Note

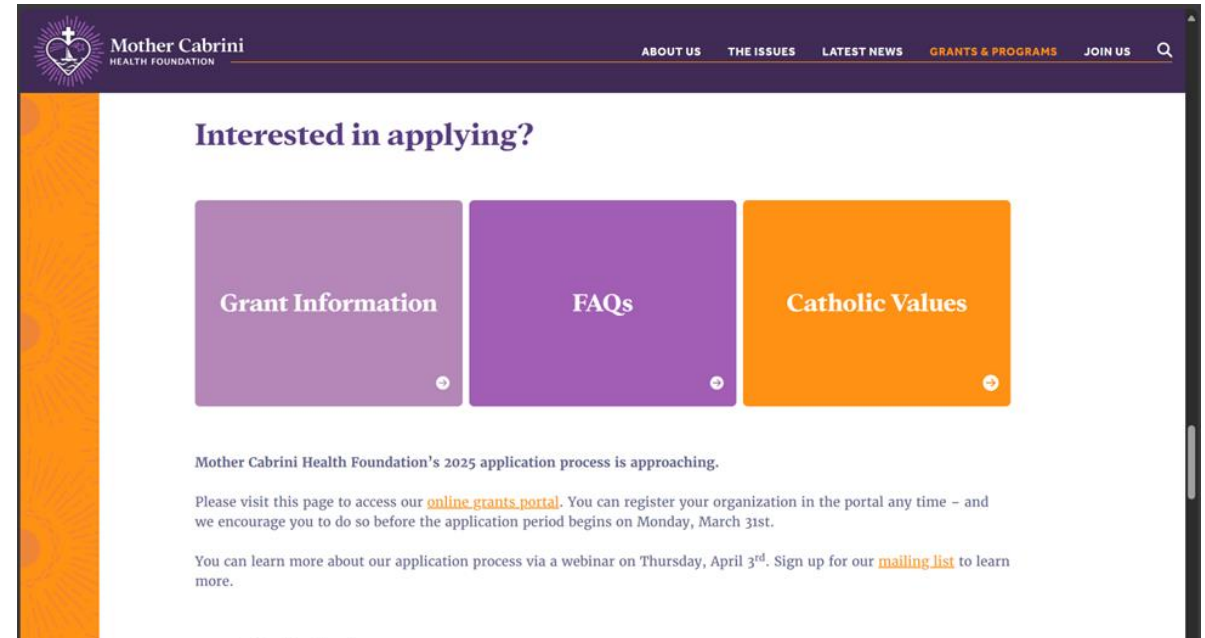
Things to Keep in Mind

- MCHF receives more than 1,000 LOIs through their open call. Though subject to change, the Foundation typically invites about one-third to submit full applications.
- Last year, UB submitted 16 LOIs. Four were invited to full proposal at half the requested amount, and two were funded.
- Focus on **direct service, not research.**
- **Impact and community partners are important!**
- Assuming that the requirements follow previous years, applicants need to **estimate numbers and characteristics of population served, and provide a timeline (typically a table in the portal) briefly outlining activity, timeframe and description.**
- **A note to current grantees:** All requests for renewal funding of currently funded projects must be submitted through this LOI process.
