## **RESOLUTION TO** Adjust Resign Deadline for Non-15 Week Sessions

**Whereas**, the following request was submitted to the Faculty Senate Academic Policies and Grading Committee by the Office of the Registrar,

Whereas, the current resign policy defines course resignation as, "any resigned course shall be included in the student's record of study with a grade of 'R', but no credits shall be accrued and neither the grade nor the credits shall be included in computation of grade point averages."

Whereas, the current resign policy states in part, "A student may unilaterally resign a course without penalty through the eleventh week of a Fall or Spring semester, and through the first two-thirds of any other academic term."

**Whereas,** the end of the eleventh week of classes is 73.33% through the semester, which is longer than the two-thirds of a session that is allocated for other academic terms.

Whereas, students are disadvantaged in non-15 week sessions by giving them less time to resign courses,

Whereas, this disproportionate amount of <u>time to resign</u> is out of alignment with the <u>add/drop policy</u>, which allows, "Proportionate instructional days for adding or dropping a course shall be set for terms whose calendar lengths differ from the Fall and Spring semesters."

Whereas, there is a need to align the resign policy with the approach taken by the add/drop policy.

## Therefore,

**Be it resolved** that the resign policy be revised in the following manner: A student may unilaterally resign a course without penalty through the eleventh week of a Fall or Spring semester, and through  $\underline{a}$  proportionate number of instructional days for any other academic term.

Be It Further Resolved, that the remainder of the current resign policy will stay unchanged.
