Whereas NYS Governor Hochul has designated UB and Stony Brook University as SUNY Flagship University campuses, and as such these campuses need to be exemplary models of shared governance, and

Whereas the UB Faculty Senate Budget Priorities Committee (FSBPC) Charge is to consult, review, report and recommend to the senate and to advise the Senior Administration on matters concerning the development of the university budget and to recommend criteria for the allocation for university budgeted funds related to the initiation, development, and implementation of the educational program, and

Whereas the 2023-2024 FSBPC has been working closely with the UB Provost and the UB VP for Finance and Administration to better understand the process and provide real-time input/advice for UB's Annual Resource Planning Process (ARPP). Details included in the Appendix below.

Whereas, although the Provost's ARPP begins in December of the academic year, the decanal units begin their academic year planning much earlier in the academic year and rarely are there any non-leadership faculty involved in this pre-ARPP school's budget process;

Whereas, at a recent UB FSBPC the Provost suggested that the faculty should get more involved in their schools pre-ARPP's budget process;

Whereas, faculty's involvement into their school's budget process, with communication modalities to be decided by the Deans in consultation with their faculty, would provide greater transparency to the UB ARPP process

Therefore be it resolved, that in the spirit of shared governance, to better help UB achieve its Mission, Vision and Goals including advancement into the nation's Top 25 public research universities, and to stay competitive with other SUNY Flagship and University Centers, the UB Faculty Senate Budget Priorities Committee, the UB Faculty Senate Executive Committee, and the UB Faculty Senate strongly urge the UB Provost to require all Deans to document a review with their faculty that seeks their faculty's input to the school's budget prior to the Dean presenting to the annual Provost's ARPP.
