Letter from President Tripathi on DACA:

Sept. 6, 2017

Dear University Community:

Yesterday, on behalf of our university, I once again publicly expressed UB's support of the Deferred Action for Childhood Arrivals (DACA) program by cosigning a letter with my fellow educational leaders from the Association of American Universities (AAU).

To further underscore our commitment to a diverse and inclusive campus community, I, on behalf of our SUNY campus, have also wholly supported SUNY Board of Trustees Chairman H. Carl McCall and SUNY Chancellor Kristina M. Johnson in urging Congress to protect the earned rights of New York State's 42,000 DACA enrollees. In calling for a fair and permanent solution for DACA participants, Chairman McCall and Chancellor Johnson state that "SUNY's commitment to diversity, equity, and inclusion will not falter."

Since 2012, DACA has enabled hundreds of thousands of young people to realize their potential through education and employment. We at UB have always upheld this commitment to providing equal opportunity for all students to pursue their life goals. Providing a permanent legal solution for DACA participants is imperative.

As I have publicly stated recently—and on many occasions in the past—our institution fully supports the DACA program. All students, including DACA students across our state and our nation, should have the opportunity to pursue their educational goals and their professional aspirations. Our mandate as a public research university is to contribute to the educated citizenry that is so critical to a robust democracy.

## STATEMENT FROM PROVOST ZUKOSKI IN RESPONSE TO FSEC AGENDA ITEM REGARDING PUBLIC CENSURE

## SEPTEMBER 6, 2017

Regrettably, I must address a matter that is on today's agenda and that is a resolution of public censure. I have deep concerns about this resolution.

A strong and productive Faculty Senate is essential to a strong and productive university. For example, as I have stated many times, the faculty own the curriculum. I have no intention of creating an adversarial relationship with the Faculty Senate, on whom I rely for advice and guidance regarding academic policy matters. We want to work together, we must work together to achieve our common academic goals, but, in order to do that, we must recognize that we have different roles and responsibilities. Recognizing and appreciating our different roles and responsibilities benefits the university. Together, it allows us to jointly address academic challenges and opportunities facing the university.

However, when the Faculty Senate chooses a path that is not in keeping with the Policies of the Board of Trustees or the collective bargaining agreement under which we all operate, there is no choice but for the president or me to respond. That is our responsibility as officers of the university.

In the matter on which this resolution is based and as I have shared orally and in writing with Chair Glick, renewal and non-renewal actions are conditions of employment governed by the Policies of the Board of Trustees and lie solely within the scope of the collective bargaining agreement between SUNY and its faculty. Again, within the university operating system, different bodies have different responsibilities.

I am deeply concerned that the Faculty Senate has chosen to discuss and publish confidential employment information. In addition to these breaches of confidentiality, the information discussed and published may not be accurate. As an officer of the university, it is my responsibility to protect the privacy of university employees. Therefore, I will not participate further in this meeting and ask that all members of the Executive Committee seriously consider what I have shared with you and the precarious precedent you may be setting today.

I ask that my comments be entered into the formal minutes of this meeting.

STUDENT REPORT TO THE FACULTY SENATE

September 6, 2017

The recent cuts to late night busing on Friday and Saturday nights will improve neither safety for students nor quality of life for residents. Speaking from experience as a longtime volunteer at the University Heights Tool Library, quality of life in the neighborhood is important and misconduct does need to be addressed.

Students should be treated as adults and be prepared to face the consequences of their decisions. There is **no excuse** for underage drinking, disruptive parties, or disrespectful conduct. This behavior should be dealt with by improving the presence of law enforcement, not by cutting safe transportation options for the entire student body because of the actions of some of their peers. That is an easy answer, but it is not the right answer.

Every student pays \$232 each semester as a transportation fee. Regardless that Uber and Lyft are now available, this decision discriminates against students who cannot afford to pay even more money to find their own transportation. It would be quite mistaken to assume that the only students using these late buses are just those going to parties.

There are many students, especially international students as well, who live in University Heights because it is the only housing they can afford. While the Yellow Line from Flint Loop to Main Circle will continue 24-hour service Sunday through Thursday, there are many students who shared with me how they will still be impacted. Architecture students often work on their studio projects late into the night on South Campus. Student drivers of the SBI Safety Shuttles can end their shifts as late as 4:00 AM. Campus Dining & Shops often have shifts running that late as well and after UB's decision last year to reduce late night buses from 6 per hour to 3, many student workers have struggled to catch rides. Furthermore, it makes little sense to provide the 24/7 library in Capen without providing 24/7 transportation for students wanting to use it.

This is a complex issue with many sides and that is why it is critical to give all stakeholders involved a voice at the table. Without any student input, this decision was a failure of shared governance. Lest we forget last year's armed robberies and student stabbing, UB is sending a dangerous message that students don't deserve a say in issues that affect our safety.

Students are angry that services we pay for were cut without our say. Parents are worried about their student's safety when they often need it the most. Bus drivers are upset about lower pay because of reduced hours. Alumni are disheartened to see this continued theme of blindsiding decisions just like last year's cuts to the athletics teams.

These are exactly the reasons why the University needs to include students and other stakeholders on issues like this from the start, not just after it hits the headlines.

I am optimistic that myself and other student leaders can work with Parking and Transportation to find a better solution. To update you all on my steps going forward, tomorrow I'll be speaking with UB's Community Relations and next week I'll be attending the monthly meeting of the University Heights Collaborative to listen to residents. I'm also bringing together students leaders to talk with Scott Weber, Laura Hubbard, and Chris Austin about this issue.

I urge the University to recognize that the best solutions to issues that we face will come as a result of collaboration between students, administration, and community members to ensure that all stakeholders have a voice at the table.
