1. Chair's Report

- a. Moment of silence for Brian Henderson (Media Studies)
- b. Equal Pay Day April 4th
- c. UBreathe Free Committee update
- d. Dr. Glick has been nominated to chair the UFS, if he wins he will have to step down as UB FS Chair. He will know more in June.
- e. Shared Governance Day was well attended and we received positive feedback
- f. April 11th is Shared Governance Continuing Education with Robin Sullivan from CEI presenting on Social Media
