

Faculty Senate Meeting Tuesday, October 16, 2018 403 Hayes Hall, South Campus 3.00-4.30pm

Meeting called to order by Chair & Presiding Officer, Phil Glick at 3pm

Agenda: Approved unanimously with changes. The changes include –
(a) due to scheduling conflicts 3 student presentations on the approved agenda have been rescheduled to the next FS meeting. (b) Sherri Darrow, UB's Director of Wellness Education Services will also present on the same topic at the next FS meeting. (c) Dean of Undergraduate education Ann Bisantz has been invited to speak about The UB Curriculum and Pathways program. (d) The FS Secretary and also Chairperson of the election committee will make an announcement about the upcoming UB FS Election for Presiding Officer and chair of the FS in November.

Minutes: Minutes of 9/18/2018 was accepted unanimously.

Chair's report:

Obituary: A moment of silence was maintained for Dr John William Ellison UB Professor of Information and library Studies who passed away on 9/11/2018. He was the first professor to deliver long-distance education via the internet at the State University of New York at Buffalo.

Breath free UB report: 40 additional signs were placed in the 'hot spots' identified by the Breathe Free UB Committee Report. This included 24 on the north campus, 7 in the Ellicott complex, 7 on South Campus and 4 at JSMBS. President Tripathi thanked the shared governance office for this effort.



GESS report: UBNow is planning an article on GESS report in the near future. The GESS report was not accepted for the November 2018 SUNY Voices Conference.

SUNY UFS Fall Plenary Meeting will be held the week of October 21st at SUNY Binghamton. Meeting highlights will be delivered by the SUNY senators from UB at the subsequent meetings.

Micro-credentials: The SUNY Trustees adopted as policy a SUNY-specific definition of micro-credentials. A SUNY micro-credential is: 1) Competency-based; 2) Endorsed by the issuing institution; 3) Developed through local faculty governance processes; and 4) Meaningful and of high quality. SUNY micro-credentials can be offered online or in the classroom and can be offered as non-credit or for-credit.

FS representation: The FSEC at its previous meeting discussed whether FSEC members could split their duties with another faculty member and the consensus was no. Of the Schools that did not have a FS representation, Schools of Architecture and Nursing now have representatives, and we look forward to representation from School of Pharmacy in the near future.

Faculty titles and promotion: Bob Granfield gave the FSEC a presentation about attempting to simplify faculty titles and at the same time create a nomenclature that would allow a Promotion track for non-Tenure Track faculty. A task force is being formed to look into this which will be cochaired by a senior faculty member, the vice provost of faculty affairs and the director of HR. The provost will charge the task force.

UBMD physician and Empire plan query: Cemal Basaran brought to the notice of the FS that some UBMD physicians are not accepting the Empire health plan. A query has been initiated into this matter.

UB Foundation transparency remains a matter of concern.

Marilyn Morris, SUNY Distinguished Professor and Chair, Department of Pharmaceutical Sciences, received the 2018 American Association of Pharmaceutical Scientists (AAPS) Distinguished Service Award. Robert Zivadinov, MD, PhD, Professor in the Dept. of Neurology, Jacobs School of Medicine and Biomedical Sciences, has received the Gold Medal Award at the International Society for Neurovascular Disease for outstanding ongoing contributions to research and education in the field. Yu-Ping Chang, PhD, RN, FGSA, FAAN, Patricia H. and Richard E. Garman Endowed Professor; Associate Dean for Research & Scholarship and Sharon Hewner, PhD, RN, FAAN, Department Chair - Family, Community & Health Systems Sciences were named, Fellows of the American Academy of Nursing. Carole Emberton, Associate Professor of history, University at Buffalo, received the National Endowment for history award to write the book, "An Intimate History of Freedom: The Biography of Emancipated Slave Priscilla Joyner."

The African-American health disparities task force in collaboration with UB researchers and local healthcare community groups and their partners received \$800,000 Center for Disease Control and Prevention grant to implement evidence based solutions to improve health and health disparities among African-Americans in Buffalo.

Gregory Fabiano, associate dean for interdisciplinary research in the Graduate School of Education in collaboration with Florida International University received \$3.3 million U.S. Department of Education grant to investigate the best way to help support and treat children with ADHD and their families.

<u>Shambhu Upadhyaya</u>, Associate Dean for Research and Graduate Education; Director, Center of Excellence in Information Systems Assurance Research and Education (CEISARE); Professor Computer Science and Engineering has received 2.4 million grant from the National Science Foundation to train the next generation of cyber security professionals.

Clinical & Research Institute on Addiction: UB has opened the Clinical & Research Institute on Addiction which represents a reorganization of Research Institute on Addiction that embeds clinical care, research and education across the entire campus.

Faculty collaboration Studio: Last week a Faculty collaboration Studio, a technological facility was opened for university pedagogical research, teaching and experimentation to advance innovation in 6 Norton Hall.

The original document and the corrected latest version are in UB Box. The Governor's office, Attorney General's office, UB Board of Trustees, and The President's office have all been working on this matter. On advice of our Parliamentarian, this has been brought to the table for changing the motion from rescind and amend to rescind and replace. The floor was opened for discussion during which it was voted by majority to remove the first whereas due to its provocative tone. The motion to change rescind and amend to rescind and replace was passed unanimously.
