  - o Matt Deck was nominated but cannot serve -- must be an EC member
  - o Charlie Baxter volunteered, unanimous approval by EC (no formal motion)
  - considering two candidates: Rachel Poole and Dan Ryan
- campus-wide surveys
  - Campus Culture (addressed at today's meeting)
  - Student Union Spaces
  - o Faculty-staff dining club in new One World Café
- TA Living Wage
  - last UB Council meeting brought in SUNY Counsel to state no public involvement was desired, complaints were raised by public in attendance, Chair Jeremy Jacobs moved into executive session to avoid public input
  - Faculty Senate budget cmt working on a resolution in support of living wage
- UB building names (per Spectrum article Feb '19)
  - UB has had 422 named spaces, some demolished/replaced over time
  - only 21 for people of color, only 26 for women

# VICE-CHAIR'S REPORT – Tim Tryjankowski

- Budget Advisory Cmt Charlie
  - New member has joined their cmt, Pamela Stephens-Jackson.
    - Motion to approve new member: Dan Kelly (Don Erb). Passed,
  - Request from Sustainable Living Cmt for funding of a road trip to consult with Colgate on campus best practices (they are recognized nationally) approx. \$225 vehicle costs
    - EC requests participation by a staffer from Facilities
    - EC requests letter of invitation from Colgate
    - EC requests timely report to EC
    - Motion to approve funding with consideration of EC requests: Dan Kelly (no second required).
    - Don Erb (chair of Sustainable Living Cmt) friendly amendment, substitute formal agenda for letter of invitation. Amendment accepted.
    - Passed unanimously.
  - Inclusion & Diversity Cmt annual conference budget \$1620 (no fee), subsidized by commercial partners, recommend \$15 fee per person, partner with students to further reduce Student Union fees
    - Motion to approve up to \$400 from general fund: Dan Kelly (Lisa Pano). Passed.
  - Awards Luncheon discussion of fees
    - Center for Tomorrow has capacity of 200
    - Expected attendance is easily 200 including 50 comps (EC, officers, guests)
    - need \$2095 at \$30 per person or \$1442 at \$35 per person
    - discussion of fee, \$35 vs \$30 (last year was \$35)
    - suggestion of reduced rate for a table but consensus was too awkward
    - Note: Three Pillars matched Banchettis much lower price

### Campus Culture Survey – Despina Stratigakos (Inclusive Excellence) & Mark Coldren (HR)

- first ever campus-wide comprehensive survey about inclusion and diversity
- pre-existing master plan included eighty objectives but not prioritized
- goal is to capture campus climate and set priorities
- anonymity to encourage candor
- separate students from employees to allow different questions
- email to person will include unique link, associated with demographics
- results will be public in cross-tabulated format but preserve anonymity
- Q/ who has expressed interest in data?
  - o decanal areas and Facilities
- Q/ what is timeline?
  - o fac-staff end by late April. Share initial results by summer
- Q/ outreach implies just full time employees?
  - O That was an error. They hope to collect part-time data too.
- Q/ what is their master vision?
  - o Interested in a candid perception of the workplace.
- Q/ will it be broken down by campus?
  - Yes, by primary location as indicated by responder.
- Q/ Facilities has 4-500 personnel with no computer access?
  - Will work directly with Facilities to facilitate access.

- Q/ Is this truly unbiased; e.g. in phrasing of questions?
  - Survey created by external firm with extensive higher ed experience. Questions were run by focus groups.
- Q/ What about adjuncts & affiliated constituents e.g. health professions, don't use UB email?
  - o Primary focus is those with normal UB status. Deans will send reminders.
- Q/ Any additional encouragements..?
  - Our voice will be heard and acted upon.
- Q/ Tell us more about privacy and anonymity. What if people share sensitive details?
  - Results will not drill down into too refined an area.
- Q/ Past surveys have similarly promised action?
  - o This time will be different.
- Q/ What about the programs skewed towards online students, they have different experience?
  - Do what they can.
