#### Discussion of fiscal planning workbook and PSS new initiatives

- Some suggestions
  - Increase in cost of doing business: venue rental, Campus Dining
  - Increase in officer stipends to include UUP raises and match Faculty Senate levels.
    Historically low, and much less than Faculty Senate, stable for 14 years before 2015.
    Probably should be equitable in total between FSS and PSS. Approximate values:
    - PSS Chair \$9,300, Vice-Chair \$2,400, Secretary \$2,400, Parliamentarian \$1,100
    - FSS Chair \$14,000, no vice-chair, Secretary \$4,000, Parliamentarian \$1,100
  - Unifying campuses
  - o Be able to support other initiatives: e.g. REUSE, Women in STEM, Diversity Summit
  - o Professional Staff Appreciation Day or Development Day
  - UB Day of Service or partner in student day of service



- Student engagement
- Staff day of service
- Common themes from comment cards and August senate brainstorming meeting: more opportunities to network; staff development; recreation & wellness; opening up the campus more to general public; community engagement; retiree engagement; social/recreation activities; staff development
- Note that some offices do not grant release time for participation in Day of Caring or similar events, so this may limit staff participation in additional volunteerism.
- Question: is there risk of our budget being reduced. Answer: not anticipated since we are very transparent, accountable, and show good ROI.
