Ms. Baker reminded the audience that the Council meeting is an open meeting and under the open meetings law, the public has the right to observe the work of public officials in, and attend and listen to, public meetings. It does not provide the public with right to speak or otherwise participate in meetings. There is no time reserved in this meeting's agenda for public comments.

## **Opening business**

#### Call to order

Chairman Jacobs called the meeting to order at 8:01 a.m.

#### Approval of minutes

Chairman Jacobs called for a motion to approve the minutes of the December 10, 2018 meeting. The motion was made by Mr. Friedman, seconded by Ms. Hoeflich, and the minutes were approved without correction.

# **Topics for discussion or action**

# Report of the Chairman

Chairman Jacobs stated in previous UB Council meetings, there have been reports on graduate student stipends. The Council appreciates these reports and notes that according to the provost, UB invested \$39.5 million in PhD stipends and tuition scholarships in the 2017-18 academic year and UB's investment has grown by \$8.4 million since 2012-2013. The Council acknowledges that much has been done to raise stipend levels, and that many students are not satisfied with the progress. However, stipends are the purview of deans and department chairs, not the Council.

# Consideration of naming resolutions

Chairman Jacobs stated there were two naming resolutions to be considered by the UB Council. Mr. Jacobs asked Mr. Rod Grabowski, Vice President for University Advancement, to provide the Council with further information about the first resolution.

Mr. Grabowski stated the first resolution is a naming of the Buhite-Dimino Center for Implant Dentistry within the UB School of Dental Medicine. Chairman Jacobs called for a motion of approval. The motion was made by Ms. Hoeflich, seconded by Mr. Friedman, and was approved unanimously.

The second resolution called for the Council's approval to honor Mr. Robert Brady for his service to the Council. Chairman Jacobs called for a motion of approval. The motion was made by Mr. Dandes, seconded by Mr. Cropp, and was approved unanimously.

At this point in the meeting, a member of the audience interrupted the business of the Council as he began speaking. Ms. Baker advised this person that this was a public meeting and not a dialogue with the public. The audience member interrupted Ms. Baker and continued to speak.

# Adjournment

Pursuant to New York State Public Officers' Law, Subsection 105, Chairman Jacobs called for a motion to adjourn to executive session to discuss the employment history of an individual. A motion was made by Ms. Hoeflich and seconded by Mr. Dandes. The meeting was adjourned at 8:05 a.m.
